- 1. The meeting started at 7:40pm when most attendees have signed in.
- 2. The meeting was specifically for taking control of management of the Parks. RB presented the case:

- 2.1. Issues with FirstPort: service and accounting. Poor budgeting, late and erroneous invoicing, high insurance costs.
- 2.2. It is found that FirstPort uses insurance companies in their same group.
- 2.3. A clause in our purchase contracts allows us to create a nominee company to take back control if we have 50% dwellings voting for this motion.
- 2.4. Details of the presentation can be found in our website.
- 2.5. A lot of questions were raised and answered at the meeting. They are summarised separately in the Q&A document in the website.
- 2.6. Voting: QR code links to the voting form were provided in the room for people to vote immediately should they choose to.
- 2.7. Email with the link to the form will be sent to RA members who couldn't attend the meeting or who were unable to put in their vote at the meeting.
- 2.8. FB posts will be published to inform those who are not RA members.
- 2.9. It was suggested that some posters can be put up around the Parks and some owners can share the link to the form via what sapp or other means.

- 3.1. Megan Wright, our councillor, also attended the meeting.
- 3.2. Paul Regan had raised the subject of the Clean-up. Megan advised that the Council could provide the tools to assist with a clean-up of The Parks.
